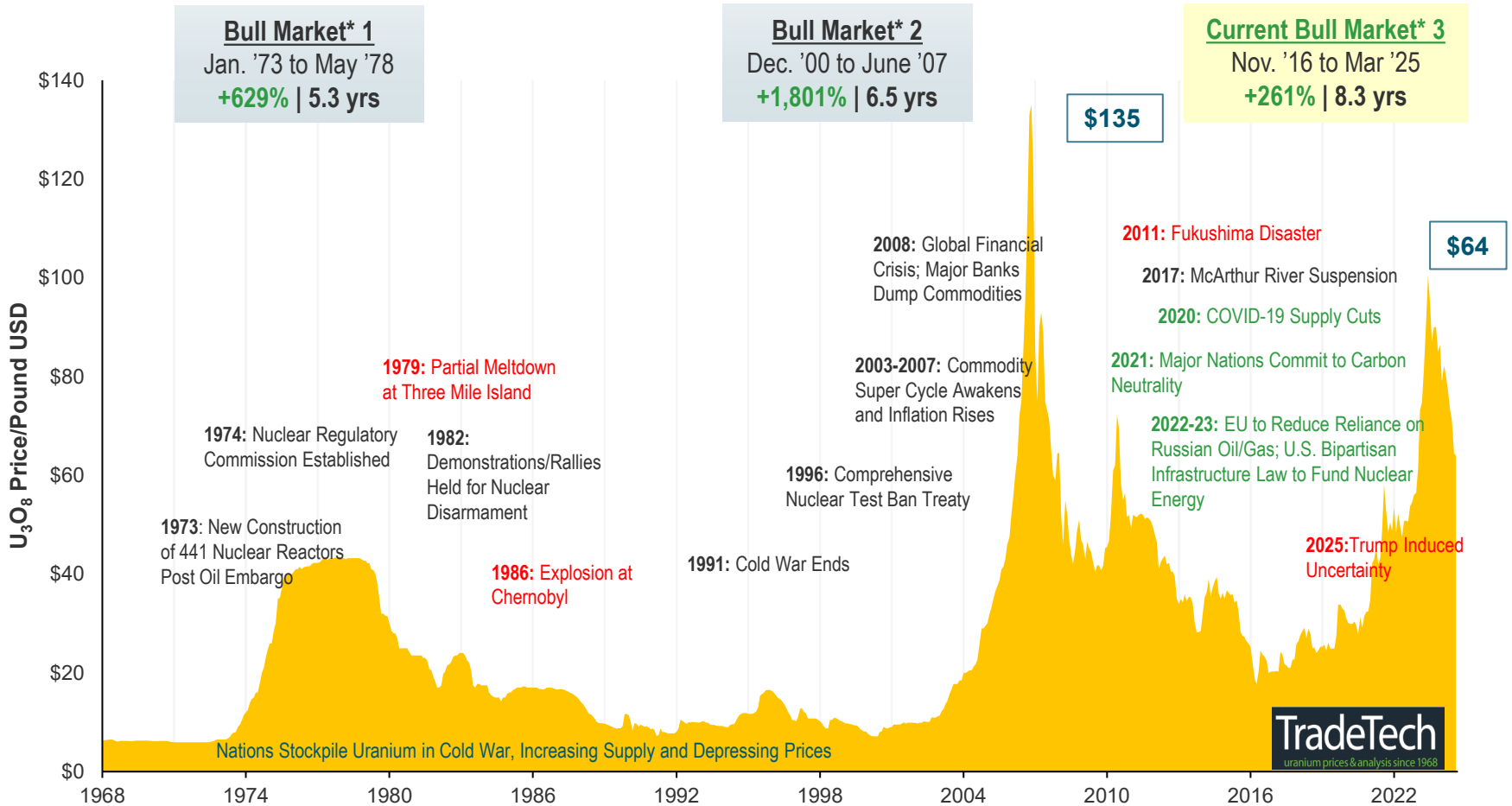


Uranium Bull is Still Intact on Long-Term Fundamentals
